

**Affidavit to be Executed by Student-Athletes
as a Condition of Eligibility to Participate in the
2008 NCAA Division I Women's Basketball Championship**

The NCAA Executive Committee has directed the NCAA Division I Women's Basketball Committee to administer a certification procedure to verify the eligibility of student-athletes participating in the Division I women's basketball championship. Please have each student-athlete that you have certified or intend to certify as eligible for participation in the championship, complete the enclosed affidavit and swear to its truthfulness before a notary public.

Please note that Question Nos. 19-28 are a result of the committee's continued concern regarding sports wagering and intercollegiate athletics.

It is suggested that you advise each student-athlete of the following information when you present the affidavit to the student-athlete:

1. There has been much publicity regarding agents or their representatives who have provided benefits to student-athletes who continued thereafter to participate in intercollegiate athletics. Thus, it is the policy of the NCAA to require every student-athlete, as a condition of participation in the NCAA Division I Women's Basketball Championship, to sign a statement under oath attesting that she has not received any benefits from an agent.
2. Swearing under oath to a false statement is a fraudulent act, which may subject the student-athlete to an NCAA Bylaw 10.1 unethical conduct violation. Also, the agent may also be subject to criminal prosecution by federal or state authorities.
3. Participation in an NCAA championship when ineligible may, negatively impact the student-athletes team. It may result in forfeiture by the student-athlete's university of all or a portion of the university's share of receipts from the competition, and in all cases can result in the team's performance being deleted from the records.
4. Any questions the student-athlete has relating to the affidavit should be addressed before signing the affidavit.
5. Information provided on this affidavit by a student-athlete could result in a violation of NCAA legislation thus deeming a student-athlete ineligible and requiring the institution to seek reinstatement.

If a student-athlete refuses to sign the affidavit, please advise Rachel Newman Baker at the NCAA national office promptly (317/917-6222). If a student-athlete answers "yes" to any of the odd numbered questions or refuses to agree to the continuing truthfulness of her answers, please forward a copy of her affidavit to Ms. Newman Baker's attention immediately. Please retain all original affidavits on file in your office. This file should be available for examination upon request by an authorized representative of the NCAA.
