

2008 Division I Board of Directors Presidential Advisory Group

Legislated

Composition. Shall consist of one president or chief executive officers from each of the 20 Division Football Championships Subdivision and Division I conferences identified in Constitution 4.2.1, seven of which shall be the current conference representatives on the Board of Directors. As a minimal goal the group membership shall include at least one person who is an ethnic minority and at least one person of each gender and a single member shall not be considered to meet both minimums.

Term of Office. The conferences shall be authorized to determine the term of office of the committee members, not to exceed four years in length. Further, after completing a four-year term of office, members of the Board may not serve again for two years. The term of office shall be annually reported to the Board of Directors and published in the NCAA Division I Manual and The NCAA News.
