**Title:** EXECUTIVE REGULATIONS -- BANNED DRUGS -- PHENYLEPHRINE

**Supplement Proposal Number:** ADM-1

**Date Submitted:** November 15, 2005

**Convention Year:** 2007

**Status:** Ready for Consideration by Management Council

**Topical Area:** Administrative Regulations

**Intent:** To remove phenylephrine from the list of banned drugs.

**Administrative:** Amend 31.2.3.4, pages 250-252, as follows:

"31.2.3.4 Banned Drugs. The following is the list of banned-drug classes. (This list is subject to change and institutions and student-athletes shall be held accountable for all banned-drug classes on the current list. The current list is located on the NCAA Web site [i.e., [www.ncaa.org](http://www.ncaa.org)] or may be obtained from the NCAA national office.)

**(a) Stimulants:**

*phenylephrine*

[31.2.3.1-(b) through 31.2.3.1-(g) unchanged.]

**Rationale:** Phenylephrine is an ingredient contained in over-the-counter medications used in the treatment of colds and influenza. Phenylephrine is considered a very mild stimulant and is not banned by the World Anti-Doping Agency. The Committee on Competitive Safeguards and Medical Aspects of Sports has recommended this action.

**Title: EXECUTIVE REGULATIONS -- SELECTION OF TEAMS AND INDIVIDUALS FOR CHAMPIONSHIPS PARTICIPATION -- IN-REGION CONTESTS DURING VACATION PERIOD**

**Supplement Proposal Number: ADM-2**

**Date Submitted: October 26, 2005**

**Convention Year: 2007**

**Status: Ready for Consideration by Management Council**

**Topical Area: Executive Regulations**

**Intent: In team sports, to count any Division III contest during a vacation period as in-region competition for ranking and selection purposes, as specified.**

**Administrative: Amend 31.3.3 by adding new 31.3.3.3, page 254, as follows:**

"31.3.3 Criteria for Selection of Participants.

[31.3.3.1 through 31.3.3.2.1 unchanged.]

**"31.3.3.3 In-Region Contests During Vacation Period. In team sports, any traditional segment contest against a Division III opponent that occurs during an official institutional vacation period may count as in-region competition for championships ranking and selection purposes under the following conditions:**

**"(a) An institution shall identify no less than four and no greater than seven consecutive calendar days of an institutional vacation period for contests to count as in-region;**

**"(b) An institution shall select no more than one institutional vacation period per sport per academic year;**

**"(c) An institution shall designate its one institutional vacation period per sport on a score reporting form and shall notify any predetermined (including both single game and tournament) opponents that the contest has been designated as in-region prior to August 15 for fall sports, October 15 for winter sports or January 15 for spring sports; and**

**"(d) Contests conducted during an institutional vacation period designated by at least one of the participating institutions will count as in-region contests for both teams.**

**"31.3.3.3.1 Waiver. There shall be no waivers granted for any condition in this section."**

[31.3.3.3 through 31.3.3.6 renumbered as 31.3.3.4 through 31.3.3.7]

**Rationale:** This policy would inject flexibility into the process of scheduling in-region contests to be used in the primary criteria during the ranking and selection process without encouraging additional missed class time by student-athletes. The application of this exception will require an institution to designate its one institutional vacation period per sport on the score reporting form submitted to the NCAA national office. The four to seven day period allows a team sufficient time to travel and compete during an official vacation period while ensuring student-athletes do not miss class time. Further, all institutions are afforded the same time period (i.e., four to seven days) to use this exception thereby ensuring competitive equity.
