Bylaws: Amend 17.1.5 by adding new 17.1.5.3, as follows:

**17.1.5.3 Athletically Related Activities During Vacation Periods. Limitations on
athletically related activities occurring during the academic year do not apply during an
institution's official vacation period when classes are not in session.**

Additional Information: The issue of required days off is nationally significant and should be
clearly described in the NCAA Division III Manual. This standard had been established in staff
interpretation (reference: 12/18/92, item a) and official interpretation (reference: 9/20/06, Item
No. 4).

Bylaws: Amend 17.02.1.1, as follows:

17.02.1.1 Athletically Related Activities. The following are considered athletically related activities:

[17.02.1.1-(a) through 17.02.1.1-(k) unchanged.]

17.02.1.1.1 Exceptions. The following activities shall not be considered athletically related:

[17.02.1.1.1-(a) unchanged.]

(b) Fundraising and community service activities not involving the use of athletics ability by student-athletes to obtain funds **provided the activities receive approval from the athletics director (or his or her designee) prior to the activity** (see Bylaw 12.5.1.1 for restrictions on promotional activities);

[17.02.1.1.1-(c) through 17.02.1.1.1-(e) unchanged.]

Additional Information: It is necessary to clarify that proper approval is necessary to use this exception to the list of athletically related activities and this clarification warrants inclusion in the Manual.
